Consent Fees under Water (Prevention and Control of Pollution) Act, 1974 and HP Water (Prevention and Control of Pollution) Consent Rule 5(5a &5b):

(i) (a) Fee for all Development Projects:

1. Consent to Establish / Operate @ Rs. 1, 00,000/- for all categories of the captive mines of major industries / development project shall be charged.
2. In case of the picking of the stone, bajari and sand from the riverbeds, the Consent to Establish / Operate fee shall be levied @ Rs. 500 and renewal @ Rs. 200 per annum.
3. The annual Consent Renewal fee shall be @ 40% of the Consent to Establish / Operate fee.

(iv) The Renewal fees in case of (i) and (ii) above shall be 40% per annum of the Consent to Establish/Operate, whereas, in case of (iii) above the Renewal fee shall be equivalent to Consent to Establish/Operate.
