Applications are invited for filling up of following posts purely on Contractual basis from the eligible candidates.

(A) Category of Posts:

(B) Desirable Qualification: It is expected from the candidates to have knowledge of local dialect, manners and customs and suitability for working in the peculiar conditions in Himachal Pradesh. Basic computer skills for R-1 would be a desirable asset.

(C) Age: Age limit for above posts shall be between 18 to 45 years.

(D) The aforesaid engagement would be **purely on contractual basis** on year to year basis and may further be extended subject to yearly renewal which would be based upon the performance assessment/review of the candidate. The renewal of contract would depend on annual performance appraisal.

(E) Selection for appointment to the posts in the case of Contract appointment will be made on the basis of written test/interview.

(F) General conditions: The H. P. State Pollution Control Board reserves the right to restrict the number of candidates to be called for the written test/ interview, if considered necessary, on the basis of qualification and experience as prescribed in the Advertisement by way of screening of applications. Those candidates, who do not fulfill the prescribed qualification as on the closing / last date of submission of application, need not apply. The date of exam/interview shall be intimated separately to all the eligible applicants.

The decision of the Chairman H.P. State Pollution Control Board shall be final and binding in all the matters concerning this recruitment.
